

SCAN, WATCH, WIN SWEEPSTAKES AND INSTANT WIN GAME

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING. NO ALCOHOLIC BEVERAGES ARE AWARDED AS PART OF ANY PRIZE.

OPEN ONLY TO ELIGIBLE LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES (EXCLUDING UTAH) AND THE DISTRICT OF COLUMBIA WHO ARE TWENTY-ONE (21) YEARS OF AGE OR OLDER AT THE TIME OF ENTRY.

VOID IN UTAH, PUERTO RICO, ALL OTHER U.S. TERRITORIES AND POSSESSIONS, AND WHERE PROHIBITED OR RESTRICTED BY LAW.

The Scan, Watch, Win Sweepstakes and Instant Win Game ("Promotion") is sponsored by Treasury Wine Estates Americas Company ("Sponsor"), 555 Gateway Drive, Napa, CA 94558 and is administered by Prize Logic, LLC ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **PROMOTION TIMING:** The Promotion begins at 12:00 PM Eastern Time ("ET") on July 22, 2019 and ends at 11:59:59 PM ET on September 14, 2019 ("Promotion Period"). The Administrator's computer is the Promotion official clock.
2. **ELIGIBILITY:** The Promotion is offered only to legal residents of the fifty (50) United States (excluding Utah) and the District of Columbia who are at least twenty-one (21) years of age at the time of entry ("Entrant"). Employees, officers, directors, representatives, and agents of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Promotion Entities"), and each of their immediate family members (e.g., spouse, parent, sibling, child, and their respective spouses and the "steps" of each, all lineal descendants, including those by adoption, regardless of where they reside) and persons living in the same household of each, whether or not related, state alcoholic beverage manufacturers, distributors, and retailers and employees of state or local alcohol beverage agencies are not eligible to enter or win. This Promotion is void in Utah, Puerto Rico, all other United States territories and possessions, and where prohibited or restricted by law. All federal, state, and local laws apply.

Participation constitutes Entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions and interpretations, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. For purposes of the Promotion, an Entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical addresses or e-mail addresses.

3. **HOW TO REGISTER FOR THE PROMOTION:** During the Promotion Period, there are two (2) ways to register for the Promotion:
 - A. **Online:** An Entrant may visit scanwatchwinLWL.com ("Website"), enter his/her date of birth and e-mail address, and complete and submit the online registration form in full and as instructed, which may include, but is not limited to, complete first and last name (no initials), street address (no P.O. box), city, state, ZIP code, date of birth, phone number, where Entrant

heard about Treasury Wine Estates, Entrant's favorite TWE wine brand, and confirmation Entrant has read and agrees to be bound by these Official Rules. All fields on the entry form must be completed unless they are indicated as optional.

- B. Living Wine Labels App:** An Entrant may use the Living Wine Labels app ("App") on his/her smartphone (App is free) and follow the instructions to access the Promotion by clicking on the Promotion banner image, and register by providing all information listed in Section 3A above. If an Entrant does not have the Living Wine Labels App, he/she can download the App to his/her smartphone.

To access the registration page on the App, an Entrant may also use the Living Wine Labels app on his/her smartphone to scan the label of any 750ml bottle of 19 Crimes, Matua, or EMbrazen Wine product. Entrant must then follow the instructions by clicking on the Promotion banner image, and then register by providing all information listed above. An Entrant will not register or earn an entry merely by scanning a wine product using the App.

- 4. HOW TO EARN SWEEPSTAKES ENTRIES AND PLAY THE INSTANT WIN GAME:** After an Entrant has registered, he/she may earn Sweepstakes entries and play the Instant Win Game as follows:

- A. HOW TO ENTER THE SWEEPSTAKES:** There are two (2) ways to receive Sweepstakes entries as set forth below. Regardless of the method of entry or combination of methods of entry, an Entrant may receive up to ten (10) total Sweepstakes entries during the Promotion Period.

- i. Qualifying Purchase and Receipt Upload: During the Promotion Period, an Entrant who is not a California resident may purchase any 750ml bottle of 19 Crimes, Matua, or EMbrazen Wine ("Qualifying Purchase") and follow the instructions at the Website or in the App. Entrant must circle the Qualifying Purchase on the receipt and upload the receipt on the Website or in the App. An Entrant who is a resident of California may not enter the Sweepstakes by making a Qualifying Purchase and uploading a receipt at the Website or App. If a resident of California uploads a receipt at the Website or App, he/she will not receive an entry. A resident of California may instead take a photo of the Qualifying Purchase product and upload the photo at the Website or in the App. Upon verification, an Entrant will receive one (1) Sweepstakes entry for each uploaded receipt (or, for a resident of California, one [1] Sweepstakes entry for each uploaded photo). Each receipt may only be uploaded one (1) time. An Entrant should keep all original receipts/photos submitted, as Sponsor may request Entrant provide an original receipt/photo for verification. Note: the Website and App will permit an Entrant to use the upload function at the Website and App no more than ten separate (10) times during the Promotion Period. Limit one (1) entry per Qualifying Purchase and receipt upload/photo upload and ten (10) total entries combined via Qualifying Purchase and receipt upload/photo upload and Mail-In Entry (as described below).
- ii. Mail-In Entry: To enter via mail and without making a purchase, an eligible Entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY) on a 3½"x5" card ("Mail-In Entry") and mail it with sufficient postage to: Scan, Watch, Win Sweepstakes and Instant Win Game, PO Box 251328, West Bloomfield, MI 48325. An Entrant will receive one (1) entry into

the Sweepstakes for a valid Mail-In Entry. All Mail-In Entries must be postmarked no later than September 14, 2019 and received on or before September 24, 2019 in order to be eligible. Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, Mail-In Entries mailed in an envelope or sent in excess of the entry limits will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries. Limit ten (10) entries via Mail-In. Also limit ten (10) total entries combined via Mail-In Entry and Qualifying Purchase and receipt upload/photo upload (as described above).

B. HOW TO PLAY THE INSTANT WIN GAME: During the Promotion Period, eligible entrants must visit the Website or App and after registering or logging-in the entrant must follow the on-screen instructions to play the Instant Win Game (“Game Play”). After the Game Play, the Entrant will receive notification on the Website screen as to whether he/she is a potential “Instant Winner” (“Notification”). Each Entrant who receives a winning Notification will be deemed a potential Instant Winner subject to verification of the Entrant’s eligibility and compliance with these Official Rules, as determined by Sponsor in its sole discretion. An Entrant is not a winner of any prize, even if the Notification should so indicate, unless and until Entrant’s eligibility and the potential winning Game Play have been verified and Entrant has been notified that verification is complete. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. Any Game Play that occurs after the system has failed for any reason is deemed a defective play, is void, and will not be honored.

Limit: There is a limit of one (1) Game Play and one (1) Sweepstakes entry per day during the Promotion Period via this method. A day is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET, except on July 22, when a date begins at 12:00 PM ET and ends at 11:59:59 PM ET. If entries are received from the same person/e-mail address in excess of the stated entry limits, the entries will be void, subject to Sponsor’s discretion. In the event that a household enters the Promotion using more than five (5) unique e-mail addresses, all of the Game Plays/entries associated with that household (determined by Sponsor or Administrator in their sole discretion) may be disqualified.

If an Entrant participates via a mobile device, message and data rates may apply. Not all cellular phone providers carry the service necessary to participate in this Promotion through a mobile device. Please check your mobile device’s capabilities for specific web enabled browsing instructions and pricing plans.

5. RANDOM DRAWING: On or about September 25, 2019, Administrator will select one (1) potential Sweepstakes winner, in a random drawing from among all eligible entries received during the Promotion Period. The winner is deemed to be a potential winner, pending verification of the Entrant’s eligibility and compliance with these Official Rules, as determined by Sponsor or Administrator, in their sole and absolute discretion.

B. Sweepstakes Grand Prizes (1): The Sweepstakes winner will have his/her choice of one (1) of the following trips (“Sweepstakes Grand Prize”):

- i. A trip for two (2) to San Francisco, California: A four (4)-night trip for the winner and one (1) guest who is at least twenty-one (21) years of age to San Francisco, California. Trip includes round-trip, coach class air transportation for two (2) from the major airport nearest Grand Prize winner’s home to San Francisco, California; one (1) double occupancy standard hotel room for four (4) nights; two (2) tickets to Alcatraz; and \$500 spending cash (for winner only).
- ii. An EMBRAZEN Travel the World package: A Tumi Latitude International Carry-On including monogram initials and a check for \$3,250.

Trip must be taken by December 31, 2020 or Sweepstakes Grand Prize will be forfeited. Travel dates are subject to availability; blackout dates and other restrictions may apply. The Sweepstakes Grand Prize winner and his/her guest must travel on the same schedule. If the winner elects to travel or partake in the Sweepstakes Grand Prize without a guest, no additional

compensation will be awarded to the winner. If winner resides within a 100-mile radius of destination, ground transportation may be provided in lieu of air transportation, and no compensation will be provided for any difference in prize value. The Sweepstakes Grand Prize winner and guest are responsible for having valid travel documents including government identification and/or passports. Sponsor bears no responsibility if any event, element, or detail of the Sweepstakes Grand Prize is canceled, postponed, or becomes unavailable for any reason. Should any event, element, or detail of the Sweepstakes Grand Prize become unavailable, the Sponsor shall have no obligation to the Sweepstakes Grand Prize winner aside from providing the remaining portion of the Sweepstakes Grand Prize, minus any unavailable event, element, or detail. The actual value of each trip may vary depending on point of departure and fluctuations in the cost of air transportation. Any difference between the estimated ARV and the actual value of the trip will not be awarded. If the winner elects to participate in the trip without a guest, no additional compensation will be provided. The ARV of the Sweepstakes Grand Prize is \$4,000. One (1) Sweepstakes Grand Prizes will be available.

C. Total ARV: The total ARV of all available prizes in the Promotion is \$15,313.25.

D. Odds of Winning/Limit: The odds of winning the Sweepstakes Grand Prize depend on the total number of eligible Sweepstakes entries received during the applicable entry period. The odds of winning an Instant Win Game Prize depend on when the entrant completes a Game Play. Instant Prizes will be made available at random times throughout the Promotion Period. To be a potential winner of an Instant Win Game Prize, an entrant's Game Play must have occurred either at the exact randomly predetermined winning time as determined by Sponsor and/or Administrator. If a Game Play does not occur at the exact randomly predetermined winning time, then the next entrant's Game Play to occur after that time will be deemed a potential Instant Winner. The number of Instant Win Game Prizes available to be won will decrease during the Promotion Period as prizes are awarded and claimed.

WINNER VERIFICATION: Each potential winner will be notified via e-mail or telephone by Sponsor or its authorized designee at the e-mail address or phone number provided at the time of registration or Mail-In Entry. Before being declared a Sweepstakes Grand Prize winner, the potential Sweepstakes Grand Prize winner will be required to execute an Affidavit of Eligibility/Liability/Publicity Release ("Affidavit"). The potential Sweepstakes Grand Prize winner must return a fully executed Affidavit to the Sponsor or its authorized designee within five (5) calendar days from the date it is postmarked as being sent to the potential Sweepstakes Grand Prize winner. If a potential winner is disqualified, is found to be ineligible, is not in compliance with these Official Rules, declines to accept a prize, or fails to return an executed and notarized Affidavit within the five (5) calendar day deadline (for a Sweepstakes Grand Prize winner), the Sponsor may, in its sole discretion, conduct a random drawing to select an alternate winner from the remaining eligible entries. A prize will go unawarded,

at Sponsor's sole discretion, if, after a reasonable effort to award the prize, Sponsor is unable to award the prize to a verified winner. Any federal, state, and local taxes imposed on the acceptance of a prize are solely the responsibility of a winner. Each Sweepstakes Grand Prize winner will be issued a form 1099 for tax purposes and must submit his/her social security number or taxpayer id number, as required by law.

Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Promotion e-mail, including any winner notification e-mail, to a spam or junk folder. The right to receive a prize is non-assignable, non-transferable and no prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of a prize or force majeure, at Sponsor's sole and absolute discretion. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. Instant Win Game Prizes will be mailed to winners at the addresses provided at registration. Please allow six (6) to eight (8) weeks for delivery. The Sweepstakes Grand Prize winner will be contacted by Sponsor or Sponsor's designee to arrange Sweepstakes Grand Prize travel. Promotion Entities shall not be held responsible for any delays in awarding a prize for any reason. Each prize will only be awarded to a verified winner.

LIMITATION OF LIABILITY:** By participating in this Promotion, Entrants agree that the Promotion Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees, and agents, ("Released Parties") are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, programming, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Promotion; (vii) any injury or damage, whether personal or property, to Entrants or to any person's computer related to or resulting from participating in the Promotion and/or accepting a prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. Further, the Promotion Entities are not responsible for any unanswered or undeliverable winner notifications.

THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN CALIFORNIA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN NAPA COUNTY, CALIFORNIA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR PROMOTION ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR OF THE TIME THE CAUSE OF ACTION OCCURRED, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.

Any attempted form of participation in this Promotion other than as in these Official Rules is void. If it is discovered that a person has registered or attempted to register more than once using multiple phone numbers, e-mail addresses, residential addresses, multiple identities, IP addresses, use of proxy servers, or like methods, all of that person's entries will be declared null and void and that person will not be awarded any prize that he/she might have been entitled to receive. Any use of robotic, automatic, macro, programmed, third party or like methods to participate in the Promotion will void any attempted participation effected by such methods and the disqualification of the individual utilizing the same.
